In this way, the philosophy and basic objectives that will set the course of our organization will be:

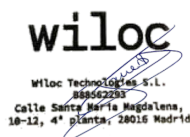
- Ensure our clients the provision of solvent and reliable services, becoming fully involved in the continuous improvement process.
